By making a UPMA PAC ACH* transfer authorization, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the UPMA, nor a part of union dues; and that UPMA PAC will use the money it receives to contribute to candidates for federal office as permitted by law. You are also making this authorization with the understanding that UPMA PAC contributions are not tax deductible and that your selection shall remain in full force and effect until you cancel by notifying the UPMA PAC in writing. You are also aware that funds will be distributed to the UPMA PAC account held at APCU and you permit APCU to identify you to UPMA for record-keeping purposes required by law.

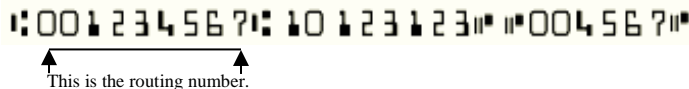
**ACH Transfer Authorization is not the same as automatic withholding from your USPS paycheck.*

- You **MUST** be an **owner** of the "From" account.
- To **CANCEL** this authorization you must contact UPMA directly in writing.
- **TRANSFER** requests will be processed on the day requested, unless the scheduled date falls on a weekend or federal holiday. In this event, the transfer will be made on the first business day following the weekend or federal holiday.
- You **WAIVE** all present and future claims against Atlanta Postal Credit Union and release APCU from all responsibility for loss or damage not caused by APCU's negligence.
- You **ACKNOWLEDGE** that you may not initiate entries that violate any of the laws of the United States.
